Old Business- Action Items

Item #1 -Adopt Amendment to section 19-4(g)(h) of Ordinance No. 9 of 2020- Electrical Rates- Junkin

The following Ordinance was introduced by Councilperson Junkin at the Special Meeting of the Mayor and Winnfield City Council held on June 23, 2020, and is presented for adoption by Councilperson Junkin at the Regular Meeting of the Mayor and City Council held July 14, 2020, to-wit:

ORDINANCE NO. 9 of2020

AN ORDINANCE TO REPEAL AND REINACT SECTION 19-4 (I AND 19-4 OF THE CODE OF ORDINANCES OF THE CITY OF WINNFIELD, TO PROVIDE FOR ANY RELATED MATTERS AND PROVIDING AN EFFECTIVE DATE THEREFOR.

BE IT ORDAINED by the Mayor and City Council of the City of Winnfield, Louisiana that Section 19I I (g) and Section 19-11 (h) of the Code of Ordinances of the City of Winnfield are hereby repealed and rein acted as follows:

19-4 (11)(g) Street Light —with no installation of pole \$15.00 per month rental

This is to be effective for new or replacement lights installed on September 1, 2020 or thereafter.

19 1 (1 1)(h) Street Light with pole installation \$350.00 pole installation

\$ 15.00 per month rental

This is to be effective for new or replacement lights installed on September 1, 2020 or thereafter.

SEVERABILITY

If any section, paragraph, clause, or provision of this ordinance shall for any reason be held invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall in no way affect the validity and enforceability of the remaining provisions of this ordinance.

REPEALER

All ordinances, parts of ordinances or chapters, sections, subsections, or paragraphs contained in the Code of Ordinances of the City of Winnfield in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that this Ordinance shall be effective on September 1, 2020.
