

The following Ordinance was introduced by Councilperson Dudley at the regularly scheduled meeting of the Winnfield City Council held on February 11, 2025, and is presented for adoption by Councilperson Dudley at the regular meeting of the Mayor and City Council held March 11, 2025, to-wit:

ORDINANCE NO. 2 of 2025

AN ORDINANCE TO AMEND SECTION 19-64 RATES FOR SEWER SERVICE: USER CHARGE OF THE CODE OF ORDINANCES OF THE CITY OF WINNFIELD, LOUISIANA, TO PROVIDE FOR ANY RELATED MATTERS, AND TO PROVIDE AN EFFECTIVE DATE THEREFOR.

BE IT ORDAINED by the Mayor and City Council for the City of Winnfield, Louisiana that the Code of Ordinances of the City of Winnfield is hereby amended by adding a section, to be numbered Section 19-64(e), which said section reads as follows:

SEC. 19-64. RATES FOR SEWER SERVICE; USER CHARGE

(e) The rates stated in this subsection shall become effective May 1, 2025, and remain in effect thereafter unless amended by ordinance.

Further provided, however, that in no event shall the residential user fee be in excess of \$45.00 per month.

It is also further provided that in the event of a water leak the commercial user fee will not be in excess of \$65.00 per month.

BE IT FURTHER ORDAINED by the City Council of the City of Winnfield, Winn Parish, Louisiana, that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED by the City Council of the City of Winnfield, Winn Parish, Louisiana that this ordinance is deemed severable and accordingly, should any part or portion hereof be declared invalid or unconstitutional, then the rest and remainder of the ordinance which can be enforced without regard to such invalid or unconstitutional part or portion shall remain in full force and effect.

BE IT FURTHER ORDAINED that this Ordinance shall be effective on May 1, 2025.

The above Ordinance was presented for adoption at the regular meeting of the Mayor and City Council of the City of Winnfield, Louisiana held on March 11, 2025.
