

The following Ordinance was introduced by Councilperson Miller at the Regular Meeting of the Mayor and City Council of the City of Winnfield held on February 13, 2024, and is introduced by Councilperson Miller for adoption at the Regular Meeting of the Mayor and City Council of the City of Winnfield held on March 12, 2024, to-wit:

ORDINANCE NO. 5 of 2024

AN ORDINANCE TO AMEND SECTION 12-51(a) OF THE CODE OF ORDINANCES OF THE CITY OF WINNFIELD, LOUISIANA, AS IT PERTAINS TO PAYMENT FOR SAID LICENSE, TO PROVIDE FOR RELATED MATTERS, AND TO PROVIDE AN EFFECTIVE DATE THEREFOR.

BE IT ORDAINED by the Mayor and City Council of the City of Winnfield, Louisiana, that Section 12-51(a) of the Code of Ordinances of the City of Winnfield, Louisiana, is hereby amended to read and provide as follows:

SEC. 12-51. REQUIRED FEE; APPLICATION; BOND PREREQUISITE TO ISSUANCE.

- a) It shall be unlawful for any itinerant vendor to sell, offer for sale, exhibit for sale, or exhibit for the purpose of taking orders for the sale thereof, any goods or merchandise, including photographs, portraits, insurance, fish, meats or any other products in the city without first obtaining a license as herein provided. The city tax collector shall issue a license to any itinerant vendor to sell, exhibit for sale, exhibit for the purpose of taking orders for the sale thereof in the city, his goods or merchandise, only after such itinerant vendor shall have fully complied with all provisions of this article and made payment of the sum of One Hundred (\$100.00) Dollars for such license, which sum shall be compensation to the city to partially defray expenses of enforcing the provisions of this chapter. This license expires 60 days from the day of issue.

SEVERABILITY

If any section, paragraph, clause, or provision of this article shall for any reason be held invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall in no way affect the validity and enforceability of the remaining provisions of this article.

REPEALER

All ordinances, parts of ordinances or chapters, sections, subsections or paragraphs contained in the Code of Ordinances of the City of Winnfield in conflict herewith are

hereby repealed.

BE IT FURTHER ORDAINED that this ordinance shall be effective upon publication hereof as provided by law and the expiration of all required legal delays.
